ORDER APPROVING THE FORM AND MANNER OF NOTICE AND APPOINTING NOTICE ADMINISTRATOR

AND NOW, On March 7, 2025, this Court granted the Direct Purchaser Plaintiffs' ("DPPs"") Motions for Class Certification under Fed. R. Civ. P. 23(b)(3) and Direct Purchaser Plaintiffs' motion for appointment of class counsel [MDL Doc. Nos. 3272, 3273]; DPPs have requested that the Court approve their proposed form and manner of notice to the certified classes informing them of the pendency of these class actions and appoint A.B. Data, Ltd. as the notice administrator tasked with effectuating notice to each class member [16-CM-27241: Doc. No. 186; 16-CB-27241: Doc. No. 249];

1. The Court finds that the proposed form of Notice to Class Members of the pendency of these Class Actions (attached as Exhibits A ("Long Form Notice") and B ("Short Form Notice")) to Joint Stipulation by DPP Bellwether Parties Concerning Direct Purchaser Plaintiffs' Motion for an Order Approving Form and Manner of Notice and Appointing Notice Administrator [16-CM-27241: Doc. No. 192; 16-CB-27241: Doc. No. 257]), and the proposed method of dissemination of notice via first-class mail, establishment of a dedicated website, and publication satisfy the requirements of Rule 23(c)(2)(B) and due process, are otherwise fair and reasonable, and therefore are approved.

2. A.B. Data, Ltd. is hereby appointed Notice Administrator for these actions.

3. Within 10 days of the entry of this Order, the Notice Administrator shall cause Notice substantially in the form of the Long Form Notice to be sent to the members of the Classes listed in Exhibit 3 to the Rebuttal Report of Dr. Leitzinger via first-class mail to the last known address of each Class Member, identified from the data or other documents produced in this case and verified through the USPS National Change of Address database. Where an appropriate email address is known to AB Data, notice shall be sent by email as well.

4. Within 10 days of the entry of this Order, the Notice Administrator shall cause the Notice substantially in the form of the Long Form Notice to be published on a dedicated website, GenericDrugDirectClasses.com, which shall also include other filings regarding the Classes.

5. Within 10 days of the entry of this Order, the Notice Administrator shall cause Notice substantially in the form of the Short Form Notice to be disseminated via publication on the Pink Sheet, via PR Newswire, and in the Wall Street Journal.

6. Members of the Classes may request exclusion from one or both Classes via email sent or letter postmarked no later than 60 days from the mailing of the Notice to the Classes in accordance with the procedures set forth in the Notice. The Notice Administrator, and Lead Class Counsel, shall monitor and record any and all opt-out requests that are received.

7. Within 14 days following the deadline for Class members to exclude themselves from the Classes, Lead Class Counsel shall file a report to the Court confirming that Notice was sent according to these procedures, and identifying the Class members, if any, who requested to

be excluded from the Classes and who meet the requirements for a valid request for exclusion as set forth in the Notice.
